June 9-13, 1980

Users of Software AG products are invited to attend the Eighth International Software AG Users' Conference, held at the Galleria Plaza in Houston, June 9-13, 1980.

As in the past, the Conference's technical agenda will include user presentations, change/enhancement sessions, workshops and a discussion of Software AG futures. Users' Group Business sessions have also been scheduled.

Conferees will choose to attend user presentations in three areas: ADABAS (and its associated products), COM-LETE, and the integrated ADABAS/COM-LETE environment. There will be concurrent presentations in these topical areas. A "Best Speaker" in each of these categories will be chosen by the Users' Group, and awarded \$1000.

In response to suggestions from last year's attendees, workshop sessions will be scheduled apart from user presentations. Among the ADABAS workshops are Restart/Recovery, Data Dictionary, DBA Tools, Education/Documentation, Performance. Concurrent COM-LETE workshops are also scheduled, corresponding to that product's Special Interest Groups. Additional workshops addressing other areas of user interest are also planned.

There will be separate Change/Enhancement sessions for ADABAS and COM-LETE. These will be organized as in previous Conferences,

providing a forum for discussion between users and Software AG.

Users' Group Business Sessions are scheduled and will include discussions and voting on the merger of the ADABAS and COM-LETE Users' Groups and the proposed Constitution. Elections for some regional representatives and product representatives will be conducted, too.

While the technical agenda is full, participants and their guests will have good opportunity for relaxation and fun. An outline of social plans can be found in this Newsletter.

Registration forms for the Conference have been included in this Newsletter.

At their first meeting, the newly created Southeast Region chose Steve Froneberger to act as their representative. Steve is from Duke Power Company.

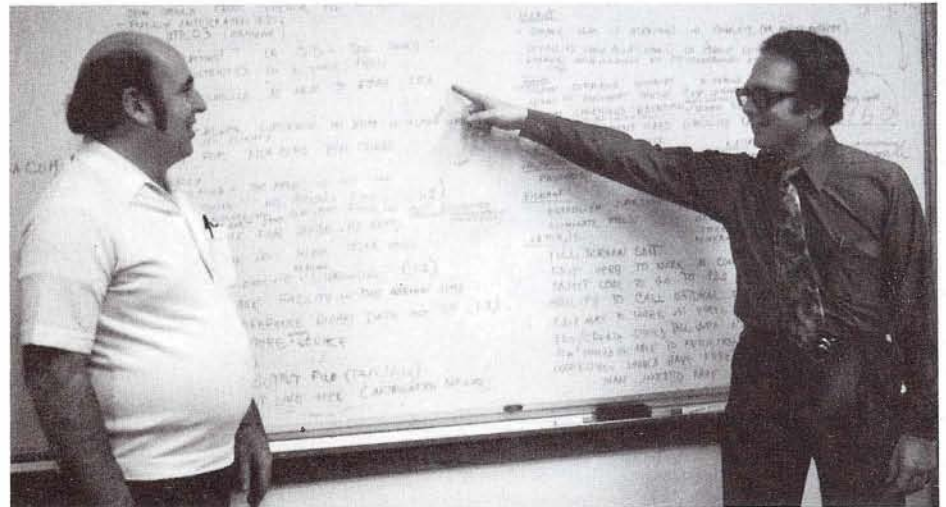

Regional Reports

Northwest Region

Fifteen users from nine installations attended the Northwest region Software AG Users Group meeting held at the Governor House Hotel in Olympia, Washington on December 7, 1979. Some interesting presentations were given by the users in attendance.

Doug Hart started the meeting by discussing a current project: ADABAS Transaction Log Analysis. A program was written by a co-worker, Hans Stoker, that provides a report summarizing CPU and I/O counts for each command executed against each file. Also a command queue depth profile for both TP and batch transactions is printed. Points of interest regarding the daily report were presented to the group. The most notable statistic shown in the report is the definite correlation between file size (number of records) and the increasing CPU time used to add a record as a file grows.

Lorna Earl of Alberta Gas Trunk Lines had a very interesting presentation on ADABAS prototyping tools. She discussed how by using TSO CLISTS to provide menus on different data base functions, users could add a data base file definition to the dictionary, run ADASCRIP, load a file into ADABAS, run data dictionary reports, etc., as well as other data base related functions.

Mike Phillips of the Washington State Liquor Control board presented the use of the Warnier-Orr diagrams as a versatile system development design tool. They are using it extensively to define not only the logical processes in an application, but also the logical design of the data base.

Steve Carter of Software AG gave an update on product release dates

and other technical details on the latest release SM tape. Minutes from the executive meeting on October 29 & 30 were also read.

The next Northwest regional meeting will be at the Vance Airport Inn at Sea-Tak on March 14, 1980.

Southeast Region

The first Users' Group meeting of the newly formed Southeast Region was held on January 22 in Atlanta at Dunfey Atlanta Hotel. Eight of the nine installations in the Southeast were represented with a total of seventeen persons present. Introductions and brief comments concerning each installation's activities with Software AG products was the first item on the agenda.

The following is a brief summary of the day's activities:

- Cathy Vivona described the organization of other regional user groups and outlined the duties of the regional representative. Cathy, along with Hank Stennes, entertained questions and comments regarding problems users have encountered with documentation and solutions to problems.
- Barbara Burns discussed the experience of R.J. Reynolds in their use of NATURAL. She covered the problems they had encountered but felt that the advantages offered by NATURAL outweighed these problems. The major facilities of NATURAL were reviewed.
- Pete Smith of the Center for Disease Control presented the objectives of their in-house training program. The three target groups identified by CDC are executives, users, and pro-

grammers. Different approaches are used for each group. Pete also mentioned that an interface between SAS and ADABAS is being investigated.

- Hank Stennes presented the major new features available in the next release of the Data Dictionary and discussed the future direction of the Data Dictionary. Online update capability through COM-LETE and CICS should be available soon. Future Software AG goals for the Data Dictionary involving increased integration of ADABAS and the Data Dictionary were discussed.
- Ken Kleinbub led a discussion on ADABAS security. E.I. Dupont has a need for strict security and has made modifications to ADABAS access modules to increase security measures. The goals of the security efforts of E.I. Dupont are to minimize the risk of loss and integrity due to unauthorized access, modification or disruption of data. The modifications made by E.I. Dupont are aiding in reaching their goals.
- Ralph Jenks explained how Dade County Public Schools has modified the "SMARTSTART" procedure developed by Doug Hart to fit their needs. Documentation on how the system works was presented to attendees. Ralph also presented output from a performance monitoring system developed at Dade County Public Schools. The output of this system comes from a parameter driven program which

processes the ADABAS log file.

- An open problem session was held at the end of the presentations.
- The next meeting is tentatively scheduled for April 16 at Duke Power Company in Charlotte, North Carolina. One topic of discussion will be Version 4.1.

United Kingdom Region

Australia

The Australian Software AG Users' Group was formed at a meeting of Australian ADABAS users in Sydney on 6th December 1979. Sixteen people attended representing four user sites, one trial user, one supplier and SPL.

The meeting started with a welcome to delegates. Geoff Holloway (SPL) welcomed the formation of the user group on behalf of SPL and Software AG. He stressed the communication benefit to be had from such a group and also the longer term pressure group benefits for the product to go in the direction that the users' require. Geoff also read a telex from Software AG stating that 4.1 was still on schedule. Colin Pratt (Tooth) welcomed the delegates on behalf of Tooth and Company and said that the formation of the user group represented a "coming of age" of ADABAS in Australia which had been achieved in a fairly short time and indicative of the quality of the product.

A representative from each company then introduced himself and any colleagues and then presented a short user profile.

Using a videotape taken at the San Diego Conference, Bob Warburton (SPL) gave a presentation on ADABAS-M which was most interesting particularly to those users contemplating future network requirements. Unfortunately neither Frank Zaknic (SPL) nor Tooth's computer were available for the NATURAL presentation so Bob filled in with the NATURAL videotape from the San Diego Conference.

Next followed a presentation on the DB/DC environment at Tooth explaining how ADABAS/CICS/Central software has been tied together with home-grown code to produce an environment at least equal (we're modest) to IMS DB/DC.

After a smorgasbord lunch, the main business of the day was addressed. It was decided to form an interim committee to establish a constitution for ratification. This constitution would embody the objectives and organization of the users' group. We also decided to establish a budget and method of funding for ratification and, of course, to plan the next meeting. This will be held in Canberra at the Australian Bureau of Statistics. The suggested date is 7th March.

The interim committee consists of Peter Wright (ACI), Peter Kazacos (OCAL), David Bird (Australian National Library), and the writer as chairman.

On 7th December Frank Zaknic (SPL) gave a course on ADABAS 4.1 facilities and conversion. Interstate user group delegates were able to stay over and hence there was a good roll up and plenty of discussion. With both Frank and the machine available, there was an added bonus of a live NATURAL demonstration.

Finally a few days ago some users had the pleasure of a flying visit from Mr. Macho himself—dynamic Dave Del Rio and benefited from his expertise; but alas once again the visit was all too short (not even enough time to wear out a keyboard).

Western Region

The Western Region has a new profile since we last reported to you. Because there is a rapidly increasing number of users in both the northern

and southern halves of the region, two sub-regional groups have been formed. The northern group, including Northern California and Nevada, is chaired by Bill Belisle of the State of California Youth Authority. The southern group, comprising Southern California and Arizona, is chaired by Walt Hopkins of Nissan Motor Corp. Yours truly was elected at the joint meeting of the two groups on January 4 to coordinate regional activities and to represent the region to the executive committee, filling the unexpired term of Jon Schmitt.

The northern sub-group held its last regularly scheduled meeting on December 5 at the California State Department of Rehabilitation in Sacramento.

Steve Clark discussed the recent meeting of the Executive Committee. Among Steve's subjects were details of the Houston conference, the current release dates for software items, the new regional structures, and some interesting rumors about the 1981 conference.

Bill Belisle informed the group that a new edition of the Public Sector Catalog is now available.

The Software AG update was given by Richard Currier. He discussed Software AG's work on IBM 4300's, the recent Software AG reorganization, and had some further comments on the '80 conference.

Paul Peterson of Software AG gave a technical presentation on restart/recovery under ADABAS 4.1. Several questions which had been raised on the subject were answered.

Sheldon Brown gave a talk on hints for adhoc reporting, which presented ideas for structuring a data base to facilitate adhoc report generation.

A round-table discussion was held in which each site described how their DBA function interfaced with the application development process.

The meeting ended with an open discussion in which each of the Software AG products was covered. As part of this it was noted that, contrary to popular opinion, a PL/I subroutine can be called from ADACOM.

The southern sub-group, formed

in June, has been having almost-monthly meetings at the sites of the various member users. The November meeting was hosted by Ticor Mortgage Corp.

Fred Willis of Ticor gave an overview of Ticor Mortgage as a subsidiary of Title Insurance offering realty tax service, title insurance, and printing services. Ken Ng discussed the current status of ADABAS at Ticor, relating installation problems and the MPM interface interference with CICS which required a zap fix. Ticor is utilizing ADACOM for report writing where feasible, but, for more complex reports DYL260 is used with an interface to ADAMINT.

Walt Hopkins presented a summary of events that took place at a U.C.L.A. seminar on relational data bases and discussed the query by example concept.

Larry Rodda of Western Region TSOP in Denver explained the operation of the technical support center, and suggested that when contacting Denver TSOP for problem resolutions the user have a maintenance log, ADAICK output, and an ADAREP of the data base at hand. Larry introduced Richard Currier, West Coast VP of Sales, and Peter Harris, Southern California's marketing support representative.

Prior monthly meetings were hosted by Hughes Aircraft, Getty Oil and Nissan Motor Corp. In addition to application overviews given by host site representatives, discussions included ADAMINT, Restart/Recovery, the Data Dictionary and DBA policies.

A joint meeting of the two sub-groups was held on January 4 at the California Youth Authority in Sacramento. Cathy Vivona, Software AG's Users' Group Liaison, was introduced to the group and subsequently participated actively in the day's activities.

The first order of business was the election of a Western Regional Representative to fill the unexpired term of Jon Schmitt, who resigned to take a position with Software AG. The election was preceded by a discussion as to whether each installation

was entitled to a vote or each user (where there are several discrete users to one installation) had a vote. The former prevailed with a resolution to introduce the matter again at the executive committee meeting in Houston. David Berg was elected to that post with Bill Belisle from the California Youth Authority designated as the backup representative.

Introduction and discussion of each member site's Change/Enhancement Requests followed, with Cathy Vivona moderating and Larry Rodda answering questions about planned product enhancements. About sixty requests were presented. The requests were colated by product and given to me for forwarding to William Thornton, the Change/Enhancement Coordinator.

The next meeting of the Northern sub-group is to be announced; that of the Southern sub-group will be February 8th at the Santa Barbara campus of the University of California.

Rocky Mountain Region

A Rocky Mountain ADABAS Users' Group Meeting was held at the Warren Technical Center in Denver on January 23, 1980. Fifteen users from eight sites attended the meeting. Software AG was represented by Western Region Manager of Technical Support, Paul Peterson, and three members of the Western Region Marketing Staff; Richard Currier, Peter Harris, and Ed Fox.

Jerry Schade gave an interesting talk on restart/recovery as implemented at the General Government Computer Center (GGCC) in Denver. They have an IBM 3033 and are a service bureau for all branches of state government. To recover from problems encountered during update programs, they have synchronized

IBM's OS checkpoint feature with the ADABAS checkpoint facility. Jerry stated that the effort it involved has proven to be worthwhile. All recovery procedures are composed of utilities provided by either IBM or Software AG. Any inquiries about this procedure should be directed to:

 Mike Quinlan of the University of Utah gave a presentation on COM-LETE user exits. The University is replacing a TP Monitor named Converse with COM-LETE. In order to provide users with the same amount of security they had under Converse, Mike has written a user exit that checks to be sure that the call is to an entry point in the called program. The called program then does an authorization check by looking in a table of authorized users. If that user-ID is not found in the table, he is not allowed to continue with the called program. Helen Hirsch gave a technical presentation on Restart/Recovery at Morgan Stanley. The goal of their system is to require as little systems or DBA support as possible to keep the MPM up.

Walter Kopica of Johnson & Johnson (New Jersey) gave a presentation on a Generalized Interactive Update System (GENIUS). The system developed at Simon Fraser University in Canada is being distributed in the U.S. by Walt Kopica.

Susan Schultz read a letter from some regional users to SAG. The letter was in response to a SAG commitment in San Diego to include user exits in the ADALOG module. The letter contained specific requests for log exit routines for performance

and chargeback information. Norman Dutton gave a brief presentation on installation considerations for NATURAL.

ADABAS News

Terminal Mapping Using Natural

One of the most useful tools a programmer has when writing on-line programs is the terminal mapping facility provided by the software. However, most mapping facilities provided by the standard programming languages are both cumbersome and time consuming for programmers. But NATURAL, an interactive programming language designed for use in the data base environment, has overcome these deficiencies with its mapping facility. With NATURAL, TP applications can be created and work in a fraction of the time that is necessary when using standard programming languages and TP mapping systems.

NATURAL'S mapping facility is independent of both the TP monitor and the type of terminal used. The programmer defines a screen for the purpose of data entry with the 'INPUT' statement. The 'INPUT' statement allows the map to be defined within the application program and allows immediate data validation and correction. NATURAL verifies that valid numeric data is entered for numeric fields. Data can be entered for a binary field through a hexadecimal constant (one internal position is represented in two input positions). Natural verifies that only valid hexadecimal data (0-9, A-F) is en-

tered for a binary field. The contents of fields may be specified for input only, display only, or display for modification using the keywords *IN, *OUT, and *OUTIN respectively. Fields specified as *IN (the system default) and *OUTIN, will create unprotected fields that may be tabbed to and written to. Fields specified as *OUT are write protected and may not be tabbed to.

The standard programming procedure to format an on-line screen using COBOL and COM-LETE'S Mapping Facility at Sacramento County is:

1. Design the display.
2. Define the map:
 - a) Define the location of the desired data within the application program's working storage section.
 - b) Define the location of a field control table within the application program that contains the field names and user requested display characteristics.
 - c) Code the assembly language statements to define the map.
3. Create a mapping request block within the application program to define the request.
4. Define the I/O buffer area.
5. Code the call statements.
6. Assemble the map.
7. Link Edit the map.
8. Catalog the map in the TP program library.

With NATURAL, all the programmer has to do is:

1. Design the display.
2. Code the NATURAL statements to define the map.

It's as simple as that! See Figure 1 and 2 for an example of a map and the NATURAL statements. Modifying the screen format with NATURAL is even easier; just make the changes in the map definition and then run the program. The standard procedure for modification of a screen using COBOL and assembler requires the programmer to change the map definition, assemble and link edit the map, uncatalog the old map, and then catalog the updated map. NATURAL'S mapping facility is not only more understandable, but it is much easier to implement.

An explanation of the NATURAL statements in Figure 2 follows:

LINE 0010

INPUT Defines the map for data entry.
 15T Tab to Column 15.
 'TEXT' The text literal within the quotes is displayed write protected.
 (I) Displays the 'text' intensified on a 3270 screen.
 / Causes line advance, one line for each /.

LINE 0020

*OUT Defines the following field, *DATG (a standard system function with today's date in the form DDMONTHNAMEYYYY), to be display only.
 EM Defines the edit mask for the field *DATG. The field will be displayed so that there is a space, represented by the special character '^', between the second and third character (the day and the name of the month).
 X(13) Defines thirteen alphanumeric positions.

LINE 0030

10X Insert 10 spaces before displaying the next element.
 SSN Name of a user defined field that data will be entered in.

(N9) Defines the preceding field, SSN, to be numeric and nine characters in length. Only numeric data will be valid in this field.

LINE 0040

(A15) Defines the preceding field, LAST, to be alphanumeric and fifteen characters in length. Any data is valid in this field.

LINE 0090

(N2.2) Defines the preceding input field, WAGE, as numeric and six characters in length with two positions to the left of the decimal, two positions to the right of the decimal, one position for the sign (this can be overridden), and one position for entering the decimal point.

The map can also be used to pass parameters from one program to another. NATURAL'S 'FETCH' statement dynamically loads a program into the same area currently occupied by the program containing the 'FETCH' statement, thus overlaying it. Parameter fields passed in a 'FETCH' statement are read by the fetched program with the 'INPUT' statement. The first 'INPUT' statement issued by the fetched program will result in the placement of all parameter field values into the fields specified in the map definition.

See Figure 3 for an example of the 'FETCH' statement and the map. This unique feature allows the programmer to write programs that can be tested either separately by entering values for the map fields through a formatted CRT screen, or in combinations where fetched programs pass parameters that fill the map fields. This feature is particularly useful in the development of structured (modular) programs for on-line systems. It is possible for a program to fetch itself, thereby allowing the programmer to use recursive programming techniques.

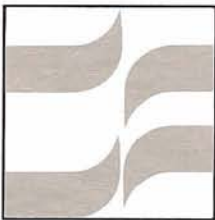

Program-1 prompts the user to enter data for individual incomes. The FETCH statement then loads Program-2 into the same area that is occupied by Program-1. The field "TOTAL-INCOME" is passed by the FETCH to Program-2 and read by the

input statement. The value in "TOTAL-INCOME" is passed to Program-2 and placed in the field "INCOME", then the computation is made and the fields are displayed. If

Program-2 were executed alone, the user would be prompted for a total-income value and the tax would then be computed and displayed.



SIG-ADABAS Special Interest Group Reports

DOS

Nine DOS users (there are perhaps 50, altogether) responded to the DOS User Questionnaire published in our September Newsletter, a respectable turn-out. From these responses, the following patterns emerge:

- $\frac{1}{3}$ of the DOS shops delegate DBA responsibility to a Systems Programmer, while the remaining $\frac{2}{3}$ have created a separate DBA or DA position.
- Most DOS users have attempted to make adjustments to the amount of real "core" available in the MPM partition in an effort to reduce system paging, and the consensus seems to be that a partition allocation of approximately 100K bytes of real "core" is sufficient to minimize paging.
- 5 of the 9 DOS installations responding have tried adjusting QMAX, but only one has been able to show a notable improvement in performance, and none of the users reported any degradation.

- And finally, only one of the 9 shops reported that they were sub-tasking the MPM in their teleprocessing partition (CICS) using HYPERVISOR.

These results would seem to indicate that most DOS installations using ADABAS are at least large enough to be able to afford to install a DBA position in their DP department. However, most of us are still deeply concerned with making ADABAS as efficient as possible, by whatever means available.

As an aside, I would like to pass on two recent experiences my own installation has had, in hopes that they may prove helpful to other DOS users. First, in May-June of 1979 we installed a software package called FASTTP, marketed by SDI. This program resides in the SVA and serves as an "accelerator" of all I/O operations for a selected partition. The interesting point to be made is that the "acceleratee" partition exhibits a 20% to 40% increase in I/O throughput capability without adversely affecting the other partitions. Second, we have developed a "dynamic password allocation" subroutine which permits us to modify passwords in a CICS application program without the need for re-compiling (or even re-linking) the CICS program. This module even

allows the DBA to modify passwords while CICS is active, simply by reassembling the subroutine. Also, the security module itself never appears in a CICS dump, thus preventing inadvertent compromising of the valid passwords presently in effect. While I would prefer not to release the source code for this module, I would be willing to furnish Software AG with a write-up of the methods and principles underlying the program's operation, so that interested users could design their own versions.

I would like to encourage DOS users to submit their profiles for inclusion in the User Profile System. In this way, we can obtain assistance from each other when problems arise.

Education

The September issue of the Newsletter contained an ADABAS Education SIG questionnaire soliciting information on how present-day ADABAS installations are educating their DBA's, Systems Designers, Program-

mers, and END Users in the use of ADABAS and its related products. As of January 7, 1980, I have received only 15 responses. Is it possible that only 15 of the 400-plus ADABAS installations world-wide are concerned with training and the direction in which Software AG's educational offerings are developed? I certainly hope not. So, on the assumption that the rest of us merely overlooked the questionnaire, I will proceed with a summary of the results.

Question 1 asked the user to identify those areas listed below where an in-house training session had been developed:

- a. ADASCRIP+ for END Users
- b. ADAMINT programming
- c. ADABAS (native "call") programming
- d. ADABAS systems development
- e. ADABAS file design
- f. ADABAS management overview
- g. Other (Please Specify).

User responses indicated the following:

- 7 users developed no in-house training programs, 4 users developed one or two programs, and 4 users developed three or more in-house sessions;
- 4 users developed ADASCRIP+ sessions,
- 4 users developed ADAMINT classes,
- 4 users developed ADABAS programming sessions,
- 1 user developed an ADABAS system development class,
- 1 user developed an ADABAS file design class,
- 4 users developed Management Overview programs,
- 2 users developed DBA concepts courses,
- 1 user developed an Internals class, and
- 1 user developed an ADABAS techniques and efficiencies class.

Question 2 asked which of the below mentioned Software AG courses the user attended:

- a. Using ADABAS
- b. ADABAS Internals
- c. The DBA
- d. Data Administration
- e. ADACOM
- f. Design Workshop
- g. Design Methodology
- h. NATURAL.

Responses were as follows:

- 1 user attended no classes
- 8 users attended a class on Using ADABAS
- 12 users attended a class on Internals
- 3 users attended a class on The DBA
- 0 users attended a class on Data Administration
- 4 users attended a class on ADACOM
- 5 users attended a Design Workshop
- 5 users attended a Design Methods class
- 0 users attended a class on NATURAL.

Question 3 sought user comments on education-related matters not covered on the questionnaire. Two users indicated that they felt Software AG's manuals, if better organized and written, could provide most of the educational material presently being developed independently by the user community. One user asked for a course to be developed for the Data Dictionary. Another user requested courses on Control, Audit, and "real world" DBA experience. And finally, several users made mention of the fact that they were new to the ADABAS community and had not been able to avail themselves of the training they felt was needed.

Overall, I feel that Software AG is responding well to user demands for improved training courses, both by their extended list of courses offered and by their avowed goal of redesigning and improving documentation. I would ask merely that consideration be given to producing audio-visual training programs on

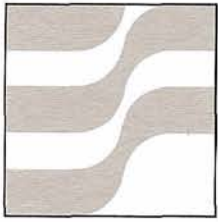
such universally applicable topics as:

- ADASCRIP+ for END users;
- ADAMINT programming;
- ADABAS (native "call") programming; and
- Management Overview.

How about some comments from my fellow users? Would you be willing to purchase such audio-visual presentations? And if so, would Software AG be willing to undertake this venture? Please write me at the address shown in the SIG chairpersons list, and I'll be glad to pass on your views and ideas.

ADABAS Technical Notes

ADABAS Under DOS/VSE (ECPS Mode) Using 3310 (FBA) Disk

At present ADABAS is working at two IBM 4331 sites in the U.S.A. (one with 512K core and with 1 MEG). These sites have IBM 3310 disk units (126016 x 512 byte blocks each).

ADABAS runs with 3310 disk (fixed block architecture) via an "INTERCEPT" routine (ADAZZRZ). This subroutine "CATCHES" all ADABAS calls to IBM's BDAM routine (IJFZZRA/IJFAZRZ) and then converts the TTR (Track/Record Address) into a LBN (Logical Block Number) for an FBA I/O subroutine (ADAFBAIO) that uses "EXCP" to communicate with the 3310 disk. The ADABAS nucleus and utilities still "use" a 3330 disk with the following block sizes:

```
ASSO = 1510
DATA = 3140
WORK = 3156
TEMP = 3140
SORT = 3140
```

ADAZZRZ and ADAFBAIO use 512 byte blocks (3310 standard) for the data base "data sets" as follows:

```
ASSO = 3 x 512
DATA = 7 x 512
WORK = 7 x 512
TEMP = 7 x 512
SORT = 7 x 512
```

Thus there is a little "wastage" of disk space, particularly in data storage. This wastage could be reduced slightly by telling ADABAS the disk type is 2314, applying disk-type zaps and converting JCL to reflect the 2314 naming requirements of ADABAS.

2 B-transient routines are also used to "INTERCEPT" ADABAS BDAM related calls: \$\$BOPEN and \$\$BCLOSE.

Another program is ADACLRDK that is used to "initialize" the disk data sets. Up to 5 (ASSOCIATOR, DATA WORK, TEMP, and SORT) may be "cleared" in 1 execution.

The main steps for using ADABAS with the 3310 disk are:

1. Assemble and CATAL (link for B-transients and ADACLRDK) ADABOPEN, ADABCLOS, ADAZZRZ, ADAFBAIO, ADACLRDK. Note: Name our BOPEN \$\$BDMDR, name our BCLOSE \$\$BDMDR2.
2. Link the nucleus and all utilities that use BDAM with the following cards...
 - include ADAZZRZ
 - include ADAFBAIO
 Note: ADAHD1 is linked with ADAHOOK. However, in some cases it does BDAM I/O directly also (not thru ADABAS) so ADAZZRZ and ADAFBAIO must be linked with ADAHD1 (ADAHD1 still will link with ADAHOOK also).
3. Rename \$\$BOPEN to \$\$BOPOLD and rename \$\$BDMDR to \$\$BOPEN all within 1 MAINT-RENAMEC-RUN. Same for \$\$BCLOSE and \$\$BDMDR2.
4. Run ADACLRDK to initialize the disk areas. This lets the loader know that there is no autorestart pending and makes for a cleaner disk.

Restart/Recovery in Version 4.1

Anticipating the release of Version 4.1, we are receiving some questions regarding implementation of restart/recovery in this new system. Here are some comments which address

some questions and concerns I've received on this subject.

1. Some users are concerned about running Version 3.2.1 batch and on-line programs without having to make program changes. It is possible to execute existing 3.2.1 load modules that use ADAHOOK and that run in MPM mode without relinking the user program. This is accomplished by providing an interface (ADALNK) that will accept the "flying zap" that ADAHOOK places into it at execution time based on the / /AENQ, etc. DD cards.
2. Users who have a large investment in V3.2.1 update programs but who wish to use the new features in V 4.1 such as file clusters, auto backout and exclusive use should plan for an orderly and thorough conversion. I would recommend that users select subsets of their entire ADABAS applications programs (hopefully the programs are broken into application "systems") and convert them one at a time. Typically, en masse conversions cause problems for everyone, not just the software house. Of course, file clusters and exclusive use users will have several new operational considerations that should be addressed by the user before conversion. In short, test, test, test, and then test once more. If we can avoid "I just converted, can't go back, and it doesn't work" as problem calls, we and the user will be happier.
3. While many V 4.1 restart/recovery features are oriented to the MPM user, it would be premature to speculate on the reduction of Single User Mode use. Single User Mode has applicability in a variety of environments. 4.1 does discuss MPM mode in much greater detail than prior documentation. This is primarily as a response to the greater emphasis by our user base on the use of MPM as the

"only" mode allowed. We do anticipate a much heavier use of MPM mode as more of the DP world becomes "on-line" oriented. The sharing of data base resources between one or more users concurrently is certainly on the increase and 4.1 is attempting to address this.

4. A large number of users (after reading the V 4.1 Planning Guide) indicated that it seemed like a good idea to make all of their update programs ET logic users and just issue one ET before the final close. This approach will work if the appropriate work space is large enough. I would not generally recommend this as a "blanket" approach to the use of 4.1 features. In the event of abnormal termination, 4.1 will have to remove all updates initiated by the user *and* the user program will have to repeat all the processing associated with the update run. This can cause an incredible amount of overhead to simply get back to where the user left off. The ET process is far better utilized as intended, where utilization consists of the application breaking into small segments the update "cycle" it is going through. It seems to me that the ideal situation (batch update program) from a user's standpoint is:

- a. Acquire the data base resources necessary to accomplish the update (one or more records from one or more files).
- b. Update them.
- c. Issue ET storing data that will allow the program to resume operations with the "next" cycle in the event of abnormal termination (via RE command).
- d. Acquire the next "transaction" and go to 1.

The only logic modification to existing programs this process would require is the issuance of ET storing a position indicator and an additional call at program initialization (the RE command to

pick up where the interrupt potentially occurred).

5. Version 4.1 recovery is primarily based on "logical transactions". While the user still has the option of using batch utilities (like ADAFIX, etc.), and automated system based on logical transaction by user is far preferable. The costs are fairly obvious. It will take additional I/O to "remember" all updates that have been processed as well as some additional CPU. The benefits are also fairly obvious. All data base update users are dealt with as individual users and can be "backed out" independently of other users of the data base. Also, the user himself can request a back out dynamically. The major advantage of this entire area is (in my opinion) that the data base and its files can be maintained automatically by the 4.1 nucleus to the most recent ET (for each user) of the data base in the event of system abend, crash, whatever.

Update on ADABAS/IMS Bridge

Software AG of the Far East has advised us that it is developing a new version (Version 2) of the ADABAS/IMS bridge. This version will consolidate the system and generalize existing capabilities of the bridge. As stated in the December Newsletter, documentation for the bridge is available through the Newsletter Editor at Software AG of North America. 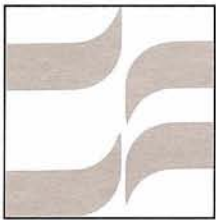

COM-LETE/ ADABAS/NATURAL Integration

4. COM-LETE/ ADABAS/ NATURAL	User Definition Facility	Security/ Control

COM-LETE Security and Accounting Special Interest Group Accounting for On-Line Use of ADABAS

A problem that many multiple user organizations have is how to account for resource use and costs as-

sociated with the use of ADABAS in an on-line environment. There are generally two main objectives for such an accounting. One is to help gauge the performance of the product in specific hardware configurations and supporting specific applications systems. The other objective is to recover costs by equitably billing the various users of the system. The question is, how does one do this?

I would like to hear from members of the Users' Group and learn how your organization has solved this problem, or if not, why. This column is an excellent place to share this information among one another, and I think we can all benefit by doing so. My address and phone number are listed in this publication, so please write me an informal note or else give

me a call and we can discuss this common concern.

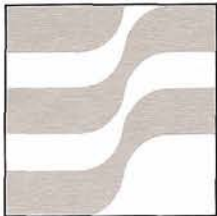
To begin this dialogue, I will list three areas in which cost and resource accounting are desirable:

1. One area in which costs certainly must be justified and perhaps billed to certain accounts, is the purchase (or lease) price of ADABAS and COM-LETE (or CICS, etc.) software. Are these costs going into some 'overhead' account which is somehow billed to individual users? In fact, do your accountants even understand what an ADABAS or COM-LETE is? When the County of Sacramento first purchased ADABAS, an accountant came into the Systems and Data Processing Department with a fixed assets inventory sticker in his

hand looking for an ADABAS to tag. Where would you have told him to stick it?

2. The second area of concern is the disk space which is occupied by ADABAS files (both data and associator). Do you charge back the cost of this space by field, file, index, or is it again lumped into 'overhead'?
3. The third area for cost and resource accounting is the MPM. The MPM resides in main memory, consumes a certain number of CPU seconds, and issues numerous EXCP's. Do you account for the MPM based on resources utilized by each user application call, or do you just divide the cost by the number of users?

These questions are just the beginning. Please contact me and we can discuss this topic further.



COM-LETE Technical Notes

Preliminary Design for File I/O and Restart/Recovery for COM-LETE Application Programs

Software AG of North America

As you may already know, we are developing a new file I/O and restart/recovery system for COM-LETE. A design group has been

established and work has been started to define the following:

- facilities and formal interface offered to COM-LETE applications programs,
- connections with COM-LETE nucleus,
- internal structure and interface between the major components, and
- content of the most important control blocks and system files.

1. Interface towards application programs

The formal interface will be as similar to the actual file I/O interface provided by COM-LETE as possible. This will allow compatibility at a logi-

cal level and automatic conversion (by means of a small bridge) between old and new requests. All standard IBM file organization will be supported with fixed, variable, undefined length records, blocked or unblocked, to the same extent as the standard IBM access methods do. All standard accesses will be supported, including the access by alternate indexes for VSAM files.

The following additional facilities which will be available are:

- records blocking for BDAM files, as supported by CICS,
- browsing on ISAM files without using QISAM, in order to allow concurrent browsings on the same file,

- browsing on PDS directories.

A particular command, TFET, will advise the recovery system that the transaction has arrived at a logical completion point so that any interruptions after this point will not affect the integrity of data. All updated records can then be released for other applications.

II. Connections with COM-LETE nucleus

A requirement of the file I/O system is that the COM-LETE nucleus "call" it in the following cases:

- 1) at system start-up, in order to set up its own environment and to manage restart operations,
- 2) at system shut-down, in order to close the activities,
- 3) whenever a roll-out occurs, in order to permit to free as much storage as possible (if necessary),
- 4) whenever an abend occurs within a thread in order to manage updated files,
- 5) each time an operator command is entered for the file I/O system,
- 6) Force rollout of application,
- 7) Program termination

In addition to that, an extension to the User Program Control Block (UPCB) will be necessary to keep control information on active transactions.

III. System architecture

For the most part, modules will be reentrant. Some will also be recursive, to allow for nesting of requests. The major components of the system are:

- I/O Interface
- Queuing
- Recovery/Restart
- Access methods interface
- System functions
- Batch emulator and utilities

a. I/O Interface

The I/O interface will receive all application program requests and will drive their processing. Basically this section will have only routing functions through the service modules of different components, at a very high logical level.

b. Queuing

The queuing system will not rely upon OS ENQ/DEQ functions but will have its own queues identified by file DDname and a minor queue name that can be a record identifier or a keyword for locks at file level or at specific function level. The queuing system will allow shared or exclusive resource control, will allow resource availability testing and will be able to recognize deadlock conditions at the time of their occurrence.

c. Recovery

1. The X-image

The basic idea upon which the recovery system will rely, consists in keeping track of each record update in the form of an "exclusive-or" between the before image and the after image of the record. This form, which will be referred to as the X-image, will allow both functions required by an online recovery system:

- updates back-out, that can be accomplished by an additional or-exclusive between the updated record and the X-image,
- updates reconstruction, that can be accomplished again by an or-exclusive operation between the X-image and the non-updated record.

The system will recognize if a record has been completely updated or not (the X-image and additional internal information are used for this purpose). The X-images written in the same sequence as the occurrences of their corresponding updates are written to a Log file. An X-image will be written before its corresponding update takes place in order to ensure the capability of backing out the update. Typically back-outs will be requested when the transaction processing is interrupted due to a system failure, a program abend or a deadlock condition. The Log file will also be used to reapply updates when files updated dur-

ing on-line operations have been damaged.

2. Minimization of Log write operations

One major goal in the design of the recovery system was to reduce to a minimum the overhead due to the recovery functions.

Therefore, all X-images generated by all active threads will be accumulated in fixed length blocks, and the physical write of a block will be deferred as much as possible. Generally, this will be written only when enough X-images have been accumulated to fill its entire length. Deferring the write of an X-image obliges the system to defer its corresponding update. So, all update operations requested by the application programs will not be executed in-line with the request but will be done asynchronously as soon as the X-image will be physically written onto the Log file. (This implies that application programs will be able to handle exceptional completions for write operations. This should be acceptable in updating existing records, where an exceptional condition is basically an I/O error which can be managed by a system exit routine; but inserting new BDAM and ISAM records, a space not found condition required to be handled in-line by the application program. Therefore such record insertions will exceptionally force the Log block to be written and will be executed in-line with the request of the application program.)

3. Minimization of Log disk space requirements

In order to save disk space, X-images will be compressed by eliminating all zero sequences (corresponding to non-updated strings of characters) and by associating with each non-zero sequence (cor-

responding to an updated string of characters) its length and displacement from the beginning of the record. Furthermore any Log blocks that have been written without being completely filled, will be rewritten with additional X-images. X-images will also be allowed to span across different Log blocks in order to ensure the maximum utilization of free space within Log blocks.

4. Main storage requirements minimization

Each read operation with the intent of update brings the physical block containing the requested record into main storage. That is kept in main storage until:

- the update is done, after the corresponding X-image has been written – in the case of required back-out, the block will have to be reread,
- a roll-out occurs – the block will be reread later, when the application program issues the update request.

In both cases the record is logically held, until the end of transaction.

5. The log subtask

Since the operation sequence 'X-images logging – file update – buffer release' takes place asynchronously with respect to the application programs, it seems convenient (in terms of coding efficiency and ease) to let such sequences be processed by a specialized subtask. This subtask will receive logging requests from threads, accumulate requests on log blocks, write log blocks when filled or when explicitly requested, check log write operations, execute file updates, free written buffers.

The two last operations will probably imply widely spread references to the virtual storage (different access methods routines and large scattered

areas for file blocks), and therefore may give page faults.

These page faults may delay the logging and updating activity for the whole system. In order to prevent this possible bottle-neck, the log task will not execute update operations and buffer releases by itself, but will activate asynchronous exit routines (by means of operating system's Interruption Requests Blocks) which will perform these operations under the TCB of the thread.

6. Transaction termination

When an application program issues the TFET command the following processing will take place:

- a special entry – logical termination – will be inserted in the stream of requests for the registration on Log file. After a logical termination has been logged, all transaction X-images will have already been logged. So, in the case of system failures, the transaction will no longer be backed out, but probably will still have to be completed;
- all file write operations will be checked for completion;
- an additional special entry – physical termination – will be inserted in the log stream, this entry is logged when the transaction has been physically completed;
- when the physical termination entry scheduled for logging, all held resources will be released for updates by the other threads.

7. Transaction recovery

A transaction recovery will take place when:

- a program abend occurs;
 - a deadlock condition is encountered;
 - a system failure occurs.
- In the first two cases a dynamic back-out is done for all updates which have been physically done at the time of the excep-

tional event. Backing out is done by reading X-images from the log file, reading updated records, checking update completion for each record, reapplying the X-image to updated records and writing them back to the user file. In the case of a system failure a warm start process automatically takes place when the system is brought up. The active transaction is determined for each thread. Depending on the status of the transaction, different actions are undertaken:

- logical termination not yet written – the updated records will be backed out with the same logic described for the case of program abends;
 - logical termination written and physical termination not yet written – the transaction will have to be completed, therefore its X-images will be scanned, records will be read and, if not yet updated, their X-image will be applied before rewriting them to the file;
 - logical and physical termination written – the transaction is completed and nothing more has to be done.
- d. Access methods interface
- This component will offer to the I/O interface a set of logical functions which will be substantially independent from the access method:
- read a block by block identifier,
 - read a block by logical record identifier,
 - write an updated block,
 - add a logical record,
 - delete a logical record,
 - check a read/write operation for its completion,
 - search a logical record within a block,
 - positioning into a PDS member,
 - alter PDS directory,
 - get a PDS directory entry.
- On the other side, this component will have interfaces towards the

following access method:

- BDAM
- BISAM
- VSAM
- BSAM
- BPAM

All interferences between conflicting operations (for example concurrent insertions and updates on ISAM files) are resolved by this component using the described queuing functions.

e. System functions

The main function of this component is to ensure an interface between the file I/O – recovery/restart system and the COM-LETE nucleus. Therefore this is basically the only component which relies on the COM-LETE environment.

f. Batch emulator and utilities

The utility programs to be used in conjunction with the file I/O and recovery/restart system are generally in the form of COM-LETE application programs. Therefore a batch emulator will be necessary in order to ensure to such utility programs the required subset of the online COM-LETE environment. In the first version of the file I/O and recovery/restart system only one utility will be provided for the reconstruction of files damaged after having been updated during online processing.

The design group estimates this project to be a 4-5 person year effort. As soon as the design is completed, a detailed implementation schedule will be published.

Documentation Status Report

As outlined at the San Diego Users' Conference, an extensive restructuring and upgrade of the documentation of the entire Software AG product line is in progress. The following is an update as to what has been accomplished to date.

The first portion of the ADABAS Version 4 manuals has been completed. This includes the Version 4 Conversion Guide, the Version 4 Command Reference Manual, and the Version 4 Programmer's Guide for TP Applications. The remaining Version 4 manuals are in the final stages of preparation.

In addition to the above manuals, extensive resources were devoted to the preparation of the NATURAL Version 1.1 documentation set. This set includes the NATURAL Installation and Operations Manual, the NATURAL Users' Guide, and the NATURAL Reference Manual. An intensive effort was made to make these manuals as effective as possible from the user's standpoint; for example, the NATURAL Reference Manual contains approximately 100 examples of NATURAL statement usage.

Revised editions of the Data Dictionary documentation (Version 1.1) and ADACOM (Version 1.2) are also being completed and are scheduled for printing in February.

Work is continuing on the ADABAS-M documentation in preparation for the upcoming release of Version 1.1 of ADABAS-M, and revised editions of the COM-LETE Version 3.0 Assembler and PL/1 Programmer's Reference Manuals are also nearing completion.

Although the emphasis is currently on the development of high quality documentation for the various new releases of software becoming available, the parallel objective of providing timely and comprehensive updates to existing manuals has not been discarded. We plan to initiate a regular documentation update service beginning in the second quarter of this year. This effort will be facilitated by the fact that all documentation created within the past eighteen months is stored online for ease of access and modification.

A summary of all current and planned documentation for the entire Software AG product line has been prepared and will be distributed in February to all users of Software AG products.

The Software AG Education Department is pleased to announce the opening of the Software AG Reston Education Center. In addition, we have available in the classroom four 3270 terminals which are connected to Software AG's Reston Computer Center. All Reston public classes beginning with the March 10-11 'NATURAL Programming' class will be held in the Reston Education Center. The Education staff recently put considerable effort into curriculum review and development for both

The COM-LETE curriculum is being expanded by the addition of the new 'COM-LETE Systems Control' course, which will be offered in a public session in Reston on May 28-30. The 'COM-LETE Applications Workshop' also is being restructured and expanded. The 'NATURAL Programming' course has been modified significantly to allow the presentation of a two-day lecture class, or a three day 'NATURAL Programming Workshop'.
