To operate on the Token-Ring Network, the IBM PC Net version of MultiMate Advantage 3.60 requires a minimum of 320K of free random access memory (RAM) with 640K recommended for optimal performance. In addition, the software requires version 1.12 of the IBM-PC Local Area Network Program.

IBM's Token-Ring Network is a high-speed communications service for interconnecting information processing equipment, such as microcomputers, at a local site.
