My involvement in All Vietnam Consulting (AVC) stems from a visit I
made to Hanoi in early December where I met with a number of Vietnam's
Government officials. Digital's Vietnamese Team had signed a number of
MOU's agreeing to work with various ministries, particularly the
Ministry of Science, Technology and Education, MOSTE.

Upon my return, the group that Mr. Nucci is associated with, AVC, requested a meeting in NYC with a Digital Government manager to discuss Vietnam IT strategies. They indicated they would be accompanied by a senior MOSTE minister I had met in Hanoi. Therefore, I was invited to attend that meeting.

During the course of the meeting MOSTE indicated they were establishing an alliance with Mr. Nucci's organization and requested that we agree to work with them. I agreed. We made plans for our respective country manager to meet after the holidays to work out the agreement.

However, Maureen Flanaghan, our Vietnam General Manager resigned in late January. AVC was then apparantly unable to make contact.

Mr. Nucci called Tom Colatasti to indicate that he was having difficulty engaging Digital in Vietnam. Tom asked me to call Mr. Nucci and see if I could reconnect him to our Vietnamese team. I did so and committed to provide the phone and fax number for our team in Vietnam. I have called him several times to convey that information to him, but he has been on travel.

I have also called our Hong Kong office and insured that they make contact with Mr. Nucci and alerted them to a possible Vietnam visit by Mr. Nucci in mid March. Finally, I have insured that our Vietnamese team has the information needed to locate the AVC General Manager in Hanoi.

At this point, we are waiting for Mr. Nucci, or his designee, to return our call. Digital's Vietnamese team is try to locate the AVC General Manager. Is there anything that I can do to follow up on Mr. Nucci's call to you?
